OFFICE ORDER

Sub: Discontinuation of National Skill Labs project at Jamia Hamdard as per the orders issued by the funding agency i.e. Ministry of Health and Family Welfare, Govt. of India

The Govt. of India, Ministry of Health and Family Welfare, New Delhi had sanctioned a project of "National Skill Labs" also called "Daksh" to Jamia Hamdard along with seven other institutions in support from Liverpool School of Tropical Medicine/LSTM in the year 2016 initially for a period of three years from 28.4.2016 i.e. from the date of signing of the Memorandum of Association between the Ministry of Health & Family Welfare and the Jamia Hamdard, New Delhi.

2. The said project tenure was extended from time to time by the sponsoring agency i.e. Ministry of Health and Family Welfare. The Ministry of Health and Family Welfare (Maternal Health Section), Govt. of India through its Under Secretary vide letter F.No. M.12015/39/2009-MCH (Ptfle) dated 27.8.2024 (copy enclosed) addressed to five institutions including the Jamia Hamdard informed that the National Skills Lab "Daksh" project tenure has been extended until 30th Sept 2024. Due to financial constraints, the Jamia Hamdard is unable to continue with the said project on its own beyond the project period. Accordingly, the National Skill Labs "Daksh" project at Jamia Hamdard comes to an end on 30th Sept 2024. The Jamia Hamdard is not liable to pay any salary of the project staff under the said project beyond the project period i.e. 30th Sept 2024.

3. All the assets created out of the project funds shall be handed over to the Principal, Rufaida College of Nursing (RCN) for further use and maintenance pending decision by the Ministry of Health and Family Welfare. The inventory of the physical assets and equipment will be prepared by the Estate Section with the help of Project In-charge/Nodal officer of the project. The pending Utilization certificate will be processed by the Nodal Officer of the project through Finance Officer for 1st April to 30th Sept 2024 immediately to settle the accounts. All concerned may take note of the same and take necessary action accordingly.


